Child care providers and anyone applying to become a licensed or registered child care provider should be aware of law related to smoking in programs. Individuals are prohibited from smoking in all facilities required to be licensed or registered for child care services. As of November 18, 2018, this includes private homes. Smoking, vaping and ...

### **Become a Provider | Division of Child Care Services | OCFS**

Group child care (center-based) provides care to three or more children, under 6 years of age, for five or more hours per week. These types of facilities operate for more than 30 days in a 12-month period.
