### STANDARD VISITATION/PHYSICAL CUSTODY SCHEDULE

The family court expects both parents to be reasonable in allowing visitation with the other parent regardless of what the actual court order requires. A. Weekend/Midweek Standard Visitation: The visiting parent shall have alternating weekends from Friday at six o'clock (6:00) p.m. until Sunday at six o'clock (6:00) p.m.

### Standard Visitation Child Custody - South Carolina Divorce

All of the standard schedules are meant to be the minimum amount of time that the non-custodial parent has with the child. Check with your local court or judge to see if there is a standard schedule for your court. Remember, if you and the other parent agree on your custody and visitation schedule, you can have any arrangements you want.

If either parent intends to move from the Commonwealth of Kentucky to another state or more than one hundred (100) miles from the present residence of the child (ren), he or she shall provide written notice to the other parent and file same with the court at least sixty (60) days prior to such move.

### Michigan Parenting Time Guideline - One Court of Justice

Sole custody means that one parent is designated as the child's primary caregiver, while the non-custodial parent may be entitled to visitation time with the child. Joint physical custody means that both parents share physical custody of the child, though the time with the child does not have to be equally divided.

### South Carolina Custody & Visitation Schedules: Samples ...

In even-numbered years the non-residential parent shall have visitation from 5:00 p.m. on the day school is out until 1:00 p.m. on Christmas Day. - The mother shall have visitation on each Mother's Day, and the father shall have visitation on each Fathers Day. Visitation shall be from 9:00 a.m. until 9:00 p.m.

Whenever this standard visitation schedule is ordered by the Court, the custodial parent is encouraged to allow additional visitation to the non-custodial parent when it would serve the best interest of the child. The custodial parent is directed to take all actions necessary to accommodate and encourage visitation with the non-custodial parent.

The change in custody or parenting time must also be in the best interest of the child. A request for modification should be filed in the same circuit court that entered the judgment you want to change. If either party lives in a different judicial district than the one that entered the judgment, you may request that the case be transferred.
